


## 2025 ELI Council Elections



### **Serving on the ELI Council**

# In 2025, ELI Fellows will elect 28 new Council Members from among the Institute's Individual Fellows.

Fellows interested in influencing the future direction of ELI are encouraged to consider running for the Council.

ELI Individual Fellows who wish to take a more active role in the Institute and help shape its future are encouraged to run for a seat on the ELI Council. It is essential that the Council reflects diversity, with a balance of gender, geography (especially from regions like the Baltic, Central and Eastern Europe, France, Ireland, Scandinavia, and Switzerland), with more practicing lawyers and judges, and legal specialisation (including administrative and criminal law experts).

Council Members elect the Executive Committee and may run for positions within it. They decide on the Institute's projects, appoint Project Team members, act as Assessors and Members Consultative Committee Chairs, approve project results, the budget, and new Member applications, among other responsibilities. Council Members can also join and lead standing committees such as the Membership and Fundraising Committees. They are encouraged to take a leading role in managing Hubs and Special Interest Groups (SIGs).

The Council meets in person twice a year, in spring and autumn, with additional remote meetings in summer and winter, to discuss specific initiatives. Reasonable travel and accommodation expenses for Council business are reimbursed by the Institute according to the <u>ELI</u> Reimbursement Guidelines.

# How to Run for the ELI Council

### Electa Platform

Elections will be conducted via Electa, a digital elections solution that strictly complies with GDPR, ISO 27001, ISAE 3000 SOC2, and Cyber Essentials Plus. Electa is trusted by organisations such as the European Parliament, UN, OSCE, the Red Cross, and Transparency International. It offers end-to-end verifiability, strong authentication methods, and is administered by Lumi Global, one of the sponsors of ELI's Annual Conference. The elections will be overseen by the Returning Officer, Prof Dr Reinhard Zimmermann, and administered by the Secretariat.

#### Eligibility

Any ELI Individual Fellow is eligible to stand for the upcoming Council elections, provided they have not already served two consecutive four-year terms. Former Council Members may stand again after four years have elapsed since their terms ended. Individual Observers may stand for election after converting their

Membership to Individual Fellow.

#### **Submission of Candidacy**

To run, the candidate must complete and upload the following to Electa by 18 July 2025:

- A nomination form; and
- A high resolution portrait photograph.

#### **Endorsement and Nomination**

Each candidate must be endorsed by five ELI Fellows by the above deadline. They can either:

- **Strongly recommended**: Solicit endorsements by five ELI Fellows through Electa;
- Submit a <u>nomination form</u> and five completed <u>endorsement</u> <u>forms</u> to the Secretariat (elections@europeanlawinstitute. eu).

Nomination forms will be completed in Electa, an electronic platform accessible to all ELI Fellows. The

number of endorsements received per candidate will be clearly visible. Each ELI Fellow may endorse an unlimited number of candidates. Candidates cannot endorse their own nomination.

#### **Publicity**

The final list of endorsed candidates will be published in early August 2025 on an electronic platform accessible to all ELI Fellows.

#### **Voting**

Elections will be held in person in Vienna on 22 and 23 September 2025 in the framework of the ELI Annual Conference. Every ELI Fellow present in Vienna will be entitled to a maximum of 28 votes (one vote per candidate). Proxy voting is allowed, with the number of proxies being limited to one per Council Fellow. Proxies must be issued in writing to the Secretariat (elections@ europeanlawinstitute.eu) by 8 September 2025. The list of proxies will be published a week later.

#### **Announcement**

Election results will be announced on 23 September 2025. The newly composed Council will convene for the first time on the same day.

# **About the ELI Executive Committee Elections**

### **Elections of Nominate Members of the Executive Committee**

At its meeting of 4 March 2025, the ELI Council unanimously elected <u>Teresa Rodríguez de las Heras Ballell</u> to serve as President, <u>Sir Geoffrey Vos</u> to assume the role of First Vice-President, <u>Pietro Sirena</u> as Second Vice-President and <u>Anne Birgitte Gammeljord</u> as Treasurer. The newly elected members of the Executive Committee will assume office in September 2025 and serve for a term of two years.

### **Elections of Innominate Members of the Executive Committee**

At its first meeting on 23 September 2025, the newly composed ELI Council will elect three new innominate Executive Committee Members who will serve a two-year term commencing in September.

Any ELI Council Fellow is eligible to stand for these positions or put the name(s) of other Council Fellows forward.

Members that have served two consecutive terms as innominate members of the Executive Committee may not stand again for the same position this year.

#### **Nominations**

Nominations must be submitted as soon as possible and at the latest at the meeting of the Council of 23 September 2025. Prior nominations can be sent to the ELI Secretariat Secretariat (elections@europeanlawinstitute.eu).

#### **Candidate Presentations**

Candidates will have the opportunity to present themselves in person at the meeting of the newly composed ELI Council of 23 September 2025.

Presentations in writing are usually reserved for candidates that are not able to join the Council meeting in person. These should be submitted to the ELI Secretariat (elections@europeanlawinstitute.eu) by 1 September 2025.

#### Voting

At the Council meeting of 23 September 2025, every Council Fellow present will have one vote. Proxy voting is allowed, with the number of proxies being limited to one per Council Fellow.

Proxies must be issued in writing to the Secretariat (elections@europeanlawinstitute.eu) and submitted at the latest at the meeting before the elections take place.

# Frequently Asked Questions (FAQ)



#### What is the ELI Council?

The ELI Council is the governing body of the Institute, comprising up to 56 elected Individual Fellows, with representation reflecting ELI's core principles. It also includes ex-officio members (the President, the two Vice-Presidents and the Treasurer and up to ten other individuals) (see Article 11 of the ELI Statute).



#### What is the ELI Executive Committee?

The ELI Executive Committee is the Institute's administrative body, consisting of the President, two Vice-Presidents, the Treasurer and three ordinary members (see Article 12 of the ELI Statute). The Executive Committee has the authority to represent the Association and is responsible for implementing decisions made by the Institute's governing bodies.



#### What is the role of project Assessors?

Council Members who serve as Assessors are part of the Advisory Committees for ELI projects. They act as peer reviewers and auditors, ensuring the quality of projects (see Article 4 of the ELI Project Guidelines).

One Assessor is selected from the Executive Committee, and one may also serve as the Chair of the MCC, when applicable.



#### How do ELI Hubs and SIGs work?

Hubs and SIGs are country-specific and topic-specific working groups created to facilitate discussions, monitor legal developments, and encourage project proposals. Each group's members appoint their chairs, and at least one Chair should ideally be an ELI Council Member (see Section 4 of the ELI Guidelines for Hubs and SIGs).



### What is the role of the Fundraising Committee?

The Fundraising Committee is a standing Council Committee focused on identifying ways to secure additional funding for ELI's activities. It supports and advises the Treasurer in this process (see CD 2011/14).



### What is the role of the Membership Committee?

The Membership Committee is a standing Council Committee responsible for developing policies to attract new members, especially from underrepresented countries, disciplines, and professions (see CD 2011/11).





#### How can I join the Fundraising Committee or the Membership Committee?

The newly elected ELI Council will appoint members to the Membership Committee and Fundraising Committee at its meeting of 23 September 2025.


Any Council Member can express their interest in serving on one or more Committees.
