Dear ELI Members and Friends

It has been my great pleasure to contribute to this year's ELI Annual Conference as keynote speaker as well as to this newsletter on a topic that lies at the very foundation of the work of both the European Commission and the European Law Institute (ELI) – the rule of law.

The rule of law is one of the founding values of the European Union, and a prerequisite for the protection of all other values. It is crucial for the effective application of EU law and for mutual trust between Member States and their judicial authorities. The Russian war of aggression against Ukraine has been a stark reminder of the importance of upholding the fundamental values of the European Union. To protect our citizens and their rights, the rule of law needs to be firmly and consistently defended across the EU.

Lawyers play a key role in ensuring the protection of fundamental rights and the strengthening of the rule of law, including the right to a fair trial. One essential element of the freedom of exercise of legal professions is respect for the confidentiality of the relationship with clients, as confirmed in the Council of Europe standards. The Commission attaches great importance to these principles and is fully committed to ensuring they are upheld.

The work of ELI – which initiates and conducts research in the field of EU law - makes an important contribution, helping to further consolidate European standards for the rule of law and to advance the legal debate in this field. In this respect, I welcome the project on the **ELI-Mount Scopus European Standards** of Judicial Independence under ELI's 'Rule of Law and the Convergence of Legal Systems in the 21st century' pillar, which aims at examining key principles of the rule of law, such as legality, legal certainty or effective judicial protection by independent and impartial courts. For each principle, it will clearly set out the relevant European and international standards. These are the same standards that also guide the Commission's policy for upholding the rule of law.

Over the past years, the Commission has developed a variety of instruments to address challenges to the rule of law. In 2020, we added the annual Rule of Law Report. The Report is at the centre of a yearly cycle, which aims at improving mutual knowledge, exchanging best practices and identifying problems at an early stage, that can then be prevented from emerging or deepening. Since 2022, the Report also includes concrete recommendations to the Member States. It looks at four key areas: national justice systems; the anti-corruption framework; media pluralism and freedom; and other institutional checks and balances. In the context of this Report, the Commission also looks closely at developments that directly concern lawyers, on issues such as legal aid and litigation costs or the protection of professional secrecy.

However, upholding the rule of law is not the sole responsibility of the Commission and the EU institutions. It also requires the engagement of all authorities in the Member States and of everyone living in Europe. This includes in particular legal professionals such as judges, prosecutors and lawyers.

Through your day-to-day work and through the research and recommendations to stimulate European legal development led by organisations such as ELI you all play a very important role in building a common culture of the rule of law in Europe.

### On the Co-Operation between ELI and the Commission

ELI and European Commission have been partners for years. Our fruitful partnership materialised in many valuable projects which I firmly believe provide great assistance to legal practitioners throughout Europe. ELI's projects constitute an essential source of information for the Commission's forward-looking initiatives and have always been a source of inspiration and a point of reference for the Commission.

Talking about synergies in our work, I would like to specifically mention the ELI project on <u>Digitalisation of Civil</u> <u>Justice Systems in Europe</u> to which we are honoured to have been invited as an observer. This project, just like our recent initiative on digitalisation of judicial cooperation and access to justice in cross-border civil, commercial and criminal matters<sup>1</sup>, aims to improve access to justice and the efficiency of judicial cooperation. At the same time, these projects ensure that digitalisation is not imposed to the detriment of fundamental rights and their full respect is guaranteed and even reinforced. I appreciate that the work that our two institutions do is complimentary, and we could offer to legal practitioners a mix of policy, financial, legislative and nonlegislative measures. For example, our digitalisation initiative introduces a legal framework for mandatory electronic communication between competent authorities in civil, commercial and criminal matters with cross-border implications. Communication by digital means in judicial procedures relating to cross-border civil and commercial matters between natural or legal persons, on the one hand, and competent authorities, on the other, will remain optional. The initiative also establishes a legal basis for the use of videoconferencing or other distance-communication technology for hearings in civil, commercial and

criminal matters with cross-border implication. The primary purpose of the ELI Principles on the Digitalisation of **Civil Justice Systems in Europe Project** is to provide an overarching framework to improve the use of digital technology in the judiciary. It bundles dispersed knowledge and research, and facilitates digitalising civil justice systems while securing fundamental values of civil procedure. Mandatory electronic exchange between competent authorities was already introduced for service of documents and taking of evidence in civil matters<sup>2</sup> and will apply as of May 2025.

The Commission also works with ELI on future-oriented projects relating to emerging technologies, like Artificial Intelligence (AI). It is likely that the use of new technologies, such as AI, will only increase in the future, so I am delighted to see that ELI and the Commission are well-aligned in examining this

A current ELI project on <u>Guiding Principles and Model</u> <u>Rules on Algorithmic Contracts</u>, in which the Commission is an observer, is very well in line with currently running exploratory projects of the Commission, examining if existing legal frameworks are adapted to the use of new technologies, for example in private transactions and contracting.

I very much look forward to ELI's project deliverables on this, which I am sure will provide a significant source of information for the European Commission.

A recently completed ELI project on <u>Principles on Blockchain Technology,</u> <u>Smart Contracts and Consumer</u> <u>Protection</u> is also a valuable instrument for the Commission's considerations in this field.

Similarly, the collaboration between ELI and the European Commission found

fruitful ground in the criminal justice area. We recently gladly participated as an observer in the ELI project on mutual Admissibility of Evidence in Criminal Proceedings in the EU, which led to the preparation of a <u>Draft Legislative</u> <u>Proposal</u> on common standards for the admissibility of cross-border evidence, including electronic evidence.

The possible adoption of minimum rules on mutual admissibility of evidence, with a view to facilitating the crossborder gathering of evidence, while ensuring strong procedural safeguards for suspects and accused persons, is an area of focus for further progress which the Commission is exploring.

I would like to conclude by mentioning the ELI project on the cross-border <u>Protection of Adults</u> finalised in March 2020.

The main findings of the project are consistent with the Commission's

legislative package<sup>3</sup> adopted this year. Indeed, the option chosen by the Commission includes a proposal aimed at authorising all EU Member States to become or remain Party to the 2000 Hague Convention on the Protection of Adults and a proposal for a Regulation to improve the crossborder protection of adults within the EU. Therefore, as suggested by ELI, both the external and the internal aspects of the problem have been considered. Several measures suggested in the ELI project have been considered in the Commission proposal for a Regulation such as the European certificate of Representation, which will help the adult's representative to assert his or her powers before non-judicial actors, for instance banks and health providers.

I am looking forward to the further cooperation with ELI on all these important initiatives.

### **Updates on ELI Projects**

The following events took place in July and August 2023.

#### New ELI Project on Enterprise Foundations in Europe

On 3 July 2023, the ELI Council adopted a new project on Enterprise Foundations in Europe, which aims at providing guidance on present approaches and solutions to foundation law in different European countries, as well as at developing a model enterprise foundation law.

The ELI project focuses on European enterprise foundations, which are important as responsible long-term owners of businesses and contributors to the public good through donations and philanthropy. Despite their significant societal impact, these foundations face legal ambiguity that limits their potential. The project aims at addressing these challenges by proposing legal solutions to regulate enterprise foundations.

The team will develop a legal definition of enterprise foundations, with a view to providing clarity on this legal construct. Through comparative legal analysis, the project will identify key sources of variation in national enterprise foundation law (including the law of functional equivalents such as trusts and companies) and explain the legal and economic implications of these choices. This will provide national and European legislators with an informed menu of options on the issue. Finally, a model enterprise foundation law and key legal obstacles which currently prevent enterprise foundation rules from being implemented by a broader set of European countries will be elaborated apon. The model law will be drafted to meet the needs from as many European countries as possible. The project, which will be completed in August 2025, is generously supported by the Enterprise Foundations project of the Copenhagen Business School.

#### New ELI Project on Foreseeable Amendments to the European Commission Proposal on the Recognition of Foreign Filiations

# On 3 July 2023, the ELI Council adopted a above project, which aims at proposing amendments to the above proposal, tabled by the Commission on 7 December 2022.

The Commission's proposal aims at establishing consistent rules on parenthood across European countries, in line with Commission President von der Leyen's commitment to universal parenthood recognition. The ELI Project Team will assess the proposed rules from four perspectives: children's rights, the rights of LGBTI individuals, women's rights, and EU primary law relating to citizen mobility. Based on its analysis, the Project Team will develop a Position Paper, in which provisions of the Commission's Proposal will be scrutinised and alternative formulations proposed. Given that the European Parliament and the Council of the EU will be examining the proposal in the forthcoming months, the ELI project will be conducted under the accelerated procedure, with the aim of producing results by February 2024. 
### **Updates on ELI Projects**

### **Updates on Other ELI Initiatives**

The following event took place in July 2023.

#### Webinar on Common Rules Promoting the Repair of Goods

On 11 July 2023, ELI held a webinar on its Feedback on the Commission's Proposal for a Directive on Common Rules Promoting the Repair of Goods, that was chaired by Pascal Pichonnaz (ELI President; Professor, University of Fribourg). Susanne Augenhofer (Chair of the ELI Feedback; Professor, University of Innsbruck) outlined ELI's feedback. Among other things, she guestioned the Commission's focus on policy options beyond the legal guarantee period instead of adjusting the Sales of Goods Directive to attain a more sustainable sales law.

René Repasi (Member of the European Parliament, Group of the Progressive Alliance of Socialists and Democrats), made various suggestions to make repair a more attractive. He was followed by Kilian Kaminski (Founder of Refurbed), who advocated a universal consumer right to repair, regardless of warranty limits, among other things, while Cristina Ganapini (Environmental Campaigner, Right to Repair Europe) stressed the need for affordable repair, including tackling practices that prevent or limit repair beyond manufacturer circles.

The webinar's penaltimate panelist, Hugh Kirk (Senior Policy Manager, DIGITALEUROPE), welcomed the Commission's proposal. He was followed by Martins Prieditis (Deputy Head of Unit B.2 'Consumer Law'; Directorate-General for Justice and Consumers, European Commission) who explained the rationale behind the Commission's policy choices.
